**ORDER DENYING REQUEST FOR TEMPORARY RESTRAINING ORDER**

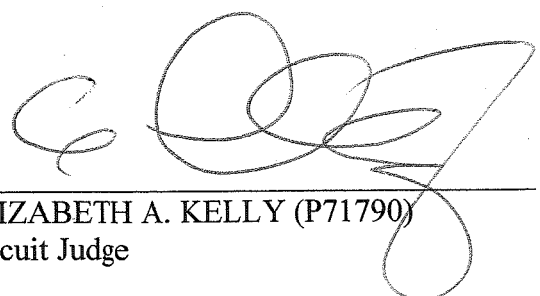
